<u>Submission of Slates – Research Grant Applications Recommended for Funding</u> Executive Director Bill Gimson presented the research grant award slates. Mr. Gimson stated, that he had six slates for this funding period. He gave a brief description of the slates recommendations.

Chairman Mansour requested that the Oversight Committee approve the appointment to the Scientific Research and Prevention Program (SRPP) Committees.

Faith Johnson moved to approve the Executive Director's appointments to the Scientific Research and Prevention Programs (SRPP) committees. Cindy Brinker Simmons seconded. None opposed. Motion carried.
